The Events Coordinator and Exhibitions Assistant report to this role.

The Producer provides research and evaluation to support development of evidence- based reports and documentation, which contributes to shaping the future of the youth arts sector whilst amplifying and elevating the impact arts and creativity has on children and young people.

This is a public sector position offered at an ASO5 for an initial 2-year contract.
