

## **Carclew Artist Network 2025: Frequently Asked Questions (FAQ)**

### **1. Who can apply to join the Carclew Artist Network?**

We welcome applications from artists at all career stages—early-career, mid-career, and established—across various arts disciplines. If you have a passion for working with children and young people and inspiring creativity through arts workshops, we encourage you to apply. Pay scale and levels of responsibilities will vary based on artist experience.

### **2. What kinds of artistic disciplines are eligible?**

Carclew works with artists from all creative disciplines, including but not limited to visual arts, performing arts, music, digital arts, and interdisciplinary forms. We're looking for artists who can bring new and exciting ideas to engage children and young people in South Australia.

### **3. What is the application deadline?**

The 2025 Artist Network Expression of Interest (EOI) submission deadline is 11:59 PM on Sunday, 17 November 2024.

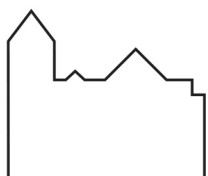
### **4. How do I submit my EOI?**

Expressions of Interests (EOIs) can be submitted through the Carclew website by completing the online application form. Make sure to include details about your artistic practice, relevant experience, and any other required documentation.

### **5. Do I need to reapply every year?**

Once selected, artists can extend their involvement for up to three years without needing to reapply.



## **6. What kind of work will I be doing if I'm selected?**

Artists in our network work across Carclew's wide range of programs, including in-school workshops, community events, and special projects like Pom Pom and Stage Sparks. You will be responsible for planning and delivering high-quality arts experiences for children and young people.

## **7. Will I receive training or support as part of the network?**

Yes, Carclew is committed to supporting our artists. An induction session will be held on 14 January 2025, with a recording available to those who cannot attend. Additionally, as part of our Artist Network you will be invited to attend a range of professional development opportunities across the year to develop your skills and knowledge about working with young people.

## **8. How will I be paid for my work?**

Carclew follows the [Carclew Artist and Arts Worker Fee Guidelines](#), which outline pay rates for artists and arts professionals. Rates are determined based on the type of work and the artist's experience level.

## **9. Do I need any special certifications to apply?**

Yes, prior to commencing all artists working with Carclew must provide an active Working with Children Check and a Responding to Risks of Harm, Abuse, and Neglect – Education and Care (RRHAN-EC) certification. You will also need to provide a National Police Clearance.

## **10. Is there an information session I can attend?**

Yes, we will be hosting an Artist EOI Information Session on 23 October 2024 at 2pm at Carclew, both in person and live-streamed. A recording of the session will be available on our website from 25 October 2024.

## **12. How will I know if my application is successful?**

We will notify all applicants of the outcome of their Expression of Interest (EOI) by 12 December 2024.

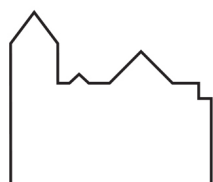
If selected, you will be invited to join our artist induction on 14 January 2025.

Once you are part of Carclew's Artist Network, you'll have the opportunity to work on various projects, collaborate with other artists, and contribute to Carclew's mission of connecting children and young people to the world of creative possibilities.



**15. Can I work in regional or remote areas?**

Yes, Carclew has a strong focus on regional and remote South Australia, and we encourage artists who are interested in working across diverse locations to apply. There will be opportunities to deliver workshops in schools and communities beyond metropolitan Adelaide.

**16. I am currently a Carclew artist. Do I still need to complete the EOI?**

Yes, all artists are required to complete the EOI to be considered for the 2025 Artist Network, including those currently working in any Carclew programs such as Carclew in Schools, Pom Pom, and Stage Sparks. This ensures we have up-to-date information about your experience and artistic practice.

**17. Why is an EOI necessary if I have already worked with Carclew?**

Carclew is expanding its programs and aims to gain a comprehensive understanding of the skillsets of both current and new artists. By submitting an EOI, you ensure that your skills and experience are matched with the most suitable opportunities within our expanding programs.

**18. Will I still be able to work in the same program I have previously worked on?**

Completing the EOI opens opportunities to be considered for all Carclew programs, giving you the opportunity to be matched to exciting new or additional roles within Carclew's diverse range of programs.
